FIRST QUARTER CRIME STATS SHOW MIXED RESULTS Some March Figures Possibly Affected by COVID-19

MEMPHIS – The Public Safety Institute at the University of Memphis and the Memphis Shelby Crime Commission have released preliminary crime figures from the Tennessee Bureau of Investigation (TBI) for the first quarter of 2020 (January-March) compared to certain previous years.

The first quarter figures show mixed results, with some results possibly affected by a change in community activity during March due to the COVID-19 pandemic.

The major violent rate is based on the aggregate number of reported murders, rapes, robberies and aggravated assaults. Compared to the first quarter of last year, the violent crime rate dropped 4.3% in the City of Memphis and 5.2% throughout Shelby County. The decline was driven by reductions in reported aggravated assaults and rapes. While making up a very small part of the aggregate major violent crime number, the most serious violent crime of murder jumped 18.9% in Memphis compared to the first quarter of last year and increased 21.6% countywide.

Reported robberies increased slightly in Memphis (+ 2.1%) and declined slightly countywide (- 1.1%) during the first quarter. However, the slight increase for the quarter was driven by a significant increase in March. In Memphis, reported robberies were 21.2% higher than in March of last year.

Major property crime is based on the aggregate number of burglaries, motor vehicle thefts and other felony thefts. The overall major property crime rate remained basically steady compared to the first quarter of last year. However, there were very significant swings in the burglary and motor vehicle theft categories.

Reported burglaries plummeted by 23.4% in Memphis and 23.8% countywide compared to the first quarter of 2019. Looking at March alone, reported burglaries in Memphis were down 24% compared to March of last year. This may be attributable to a significant number of citizens staying at home in March due to the COVID-19 crisis.

At the same time, reported motor vehicle thefts skyrocketed by 23.6% in Memphis and 21.7% throughout Shelby County. In March alone, reported motor vehicle thefts in Memphis were up 31.5% compared to March of 2019.

In past years, reported robberies and vehicle thefts have tended to increase during the summer months when schools are not in session. Due to spring breaks coupled with the COVID-19 crisis, schools were closed for most of March.

“Based on preliminary figures from the Memphis Police Department, the significant increases in reported robberies and motor vehicle thefts and significant decreases in reported burglaries in March continued during the first two weeks of April,” said Bill Gibbons, executive director of the Public Safety Institute and president of the Crime Commission.

Reported domestic violence incidents were down during the first quarter compared to 2019 – by 3% in Memphis and 3.2% countywide. And in March alone, reported domestic violence incidents were down 9.3% in Memphis compared to March of 2019.

However, Gibbons gave a word of caution on the domestic violence figures.

“It is very possible that many victims of domestic violence feel trapped during the COVID-19 crisis, feeling it is unsafe to call 911 with perpetrators remaining close by in the home and with no alternative places to go for safety. Even under difficult circumstances, victims should always try to safely seek help,” Gibbons said.

The TBI also measures 54 different categories of crime (called Group A crimes) to get a picture of the overall crime rate. During the first quarter, the overall Group A crime rate dropped 2.2% in Memphis and 4.4% throughout the county.

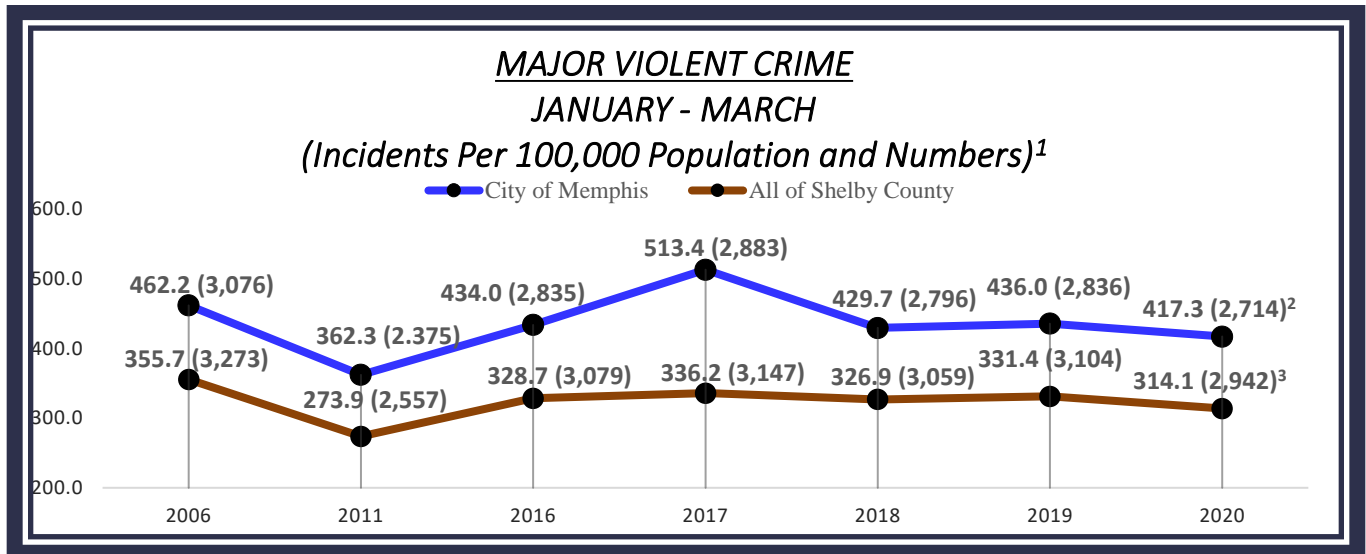
About the Crime Statistics: In measuring overall crime rates and trends, the Memphis Shelby Crime Commission and the Public Safety Institute use data reported by local enforcement agencies to the Tennessee Incident Based Reporting System (TIBRS), which was developed and is maintained by the Tennessee Bureau of Investigation. An incident is defined in TIBRS as “one or more offenses committed by the same offender or group of offenders acting in concert, at the same time and place.” Certain types of violent crimes and domestic violence offenses, however, uniquely refer to a victim count versus an incident count. All rates are calculated based on per 100,000 population.

About the Memphis Shelby Crime Commission (www.memphiscrime.org): Memphis Shelby Crime Commission is an independent, non-profit 501(c) (3) organization that “quarterbacks” the work of the Safe Community Plan and its partners. 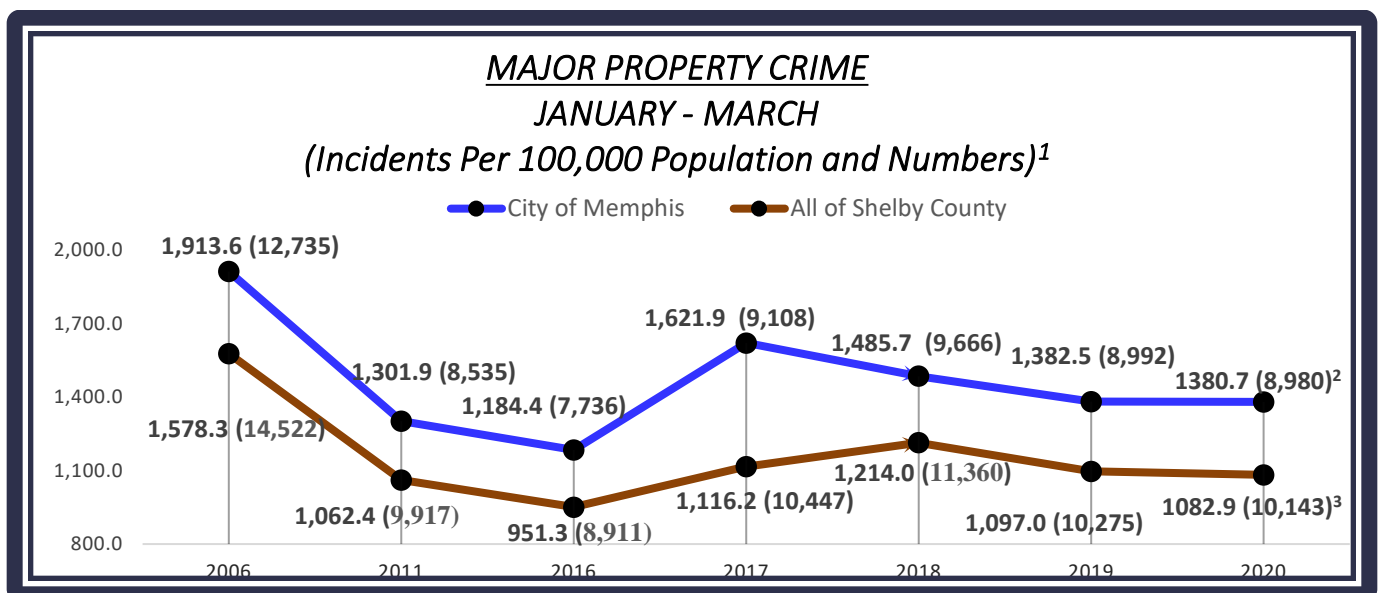

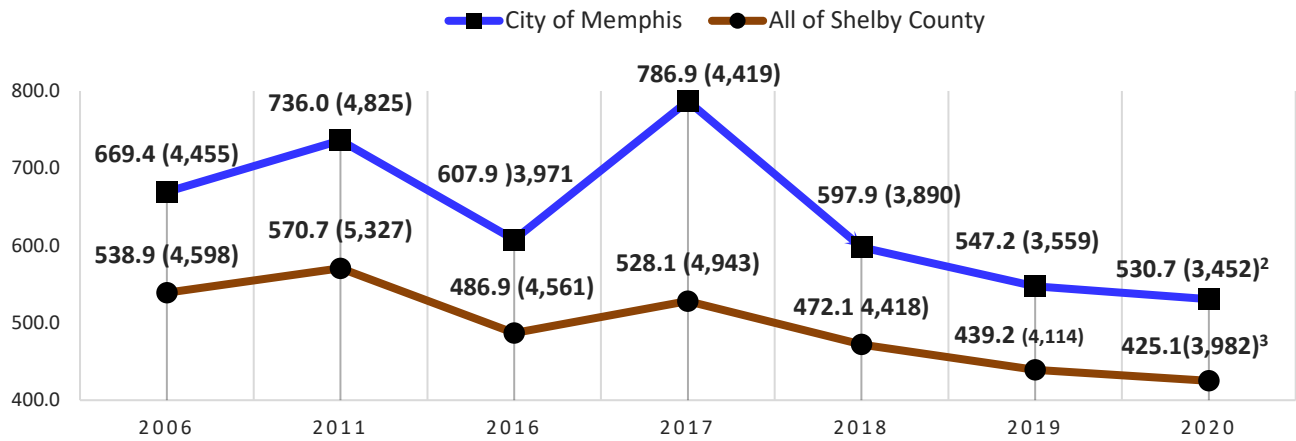

(RATE PER 100,000 POPULATION AND NUMBERS)¹

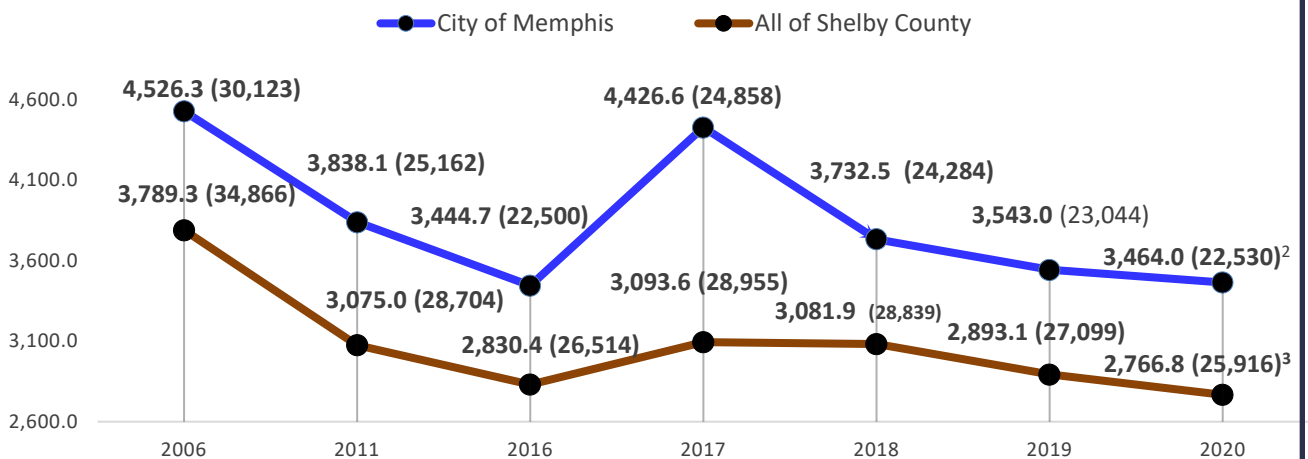
